

## **PAINFUL GUMS • IRRITABILITY**

The symptoms of teething are not limited to inflamed and painful gums — they often include restlessness, excessive chewing and drooling, and digestive troubles. These symptoms usually resolve spontaneously once the tooth has pierced the gum line.

Camilia® is a convenient and reliable homeopathic medicine for teething. The tasteless solution is absorbed sublingually without numbing the gums or affecting the gag reflex, so it will not interfere with nursing.

Camilia combines three plant-based active ingredients to relieve teething pain, irritability, and minor digestive upsets sometimes associated with teething. Each liquid dose is pre-measured for controlled dosing and hygiene. There's no numbing effect, so Camilia won't affect the gag reflex or interfere with nursing.

In an observational study conducted from 2008 to 2009, Camilia was compared to two teething gels.<sup>1</sup> The study involved 190 French pediatricians and 597 children, age 3 months to 24 months. Most pediatricians (82%) reported being satisfied with Camilia, and 71.5% preferred Camilia over the other medications. Most of the children's parents (77%) were satisfied with Camilia, and 85% said they would use it again.\*
